## 1.1 PURPOSE OF MEETING

- 1.1.1 An attempt to create a federation of London Police Monitoring Groups had failed.
- 1.1.2 There is a need to collate data from existing agencies(GLAD &SWITCHBOARD) and to service the various Law Reform Groups.
- 1.1.3 There are specific needs for police accountability to gays & an organization to monitor police treatment of gays. To this end we intend to gather information and put a case.
- 1.1.4 Our brief is police practice and not law reform.

## 1.2 EXISTING AGENCIES

- 1.2.1 These should be used where sympathetic but do not have gays as a priority. In any event, it was argued, only gays can speak forcefully for gays.
- 1.2.2 GLAD is under-subscribed.
- 1.2.3 CAPA operates a 24-hour help and support service and has a policy of non-liaison with the police. The local press ("East London Advertiser") in its area is hostile.
- 1.2.4 All the agencies see a need for visible independence of the police and have as their aim accountability to local communities. Some operate surgeries.

#### 1.3 FACTORS PECULIAR TO LONDON

- 1.3.1 The police are directly accountable to the Home Secretary.
- 1.3.2 The size of the GLC area could lead to dissipation of energy.
- 1.3.3 One means of concentrating effort might be a "flying gay picket" to deal with specific problems.

#### 1.4 THE GLC

- 1.4.1 The monitoring groups encouraged by the GLC see their functions differently from borough to borough.
- 1.4.2 Many areas are now covered but the whole of Greater London is not yet blanketed.
- 1.4.3 The next opportunity for a grant application is 09/82 and thereafter at 6-weekly intervals.

#### 1.5 POSSIBLE GROUP ACTION

- 1.5.1 Encourage awareness of civil rights (e.g. on arrest at present lamentably low).
- 1.5.2 Encourage public awareness which must be achieved by a strong gay initiative backed up by firm evidence.
- 1.5.3 Obtain secondary information from gay, community & alternative groups.
- 1.5.4 Obtain primary information from a survey over one week? of cases heard in a Magistrates Court. Bow St. / Marylebone will be excluded in view of the size and specialisation of the local vice squads in those areas. An inner London court will be selected.
- 1.5.5 John Hein agreed to reconnoitre the Horseferry Rd. court and report to Brian Stockdale.
- 1.5.6 Tactics for the survey will be considered before the next meeting. In particular please think about:-

- 1.5.7 The above should provide a statistical guide to the use of police resources.
- 1.5.8 The recent LT case (?Micky Green) has shown that political pressure (by Ken Livingstone)can successfully be brought to bear.

# 1.6 OTHER MATTERS

- 1.6.1 There was some discussion of police corruption in the matter of licensing laws.
- 1.6.2 There was mentioned the difficulty of access to (?internal) police statistics.
